Introduction

The Information we collect and the uses to which we put it...

Anonymous information

Our systems collect the IP addresses of all visitors to the site. We use these addresses to administer and improve the site and for statistical purposes but IP addresses do not in themselves identify individual visitors and we do not collect other information that might allow us to identify individual visitors except where you disclose your details voluntarily.

Personal information

If you register with the site to subscribe to our mailing list or to contact us for any reason which is optional, you will be asked to give us some information about yourself. - we will make sure, however, that no personal information about you is disclosed to other users unless you explicitly choose to disclose the information.

When we collect personal information through screens on the site - for example, in the subscription form - we use asterisks to indicate the minimum information that needs to be provided so that we can make use of the information provided - for example, so that we can process your registration. Other information is optional and no consequences will follow if you do not provide it.

We use the personal information that we collect about you in order to enable us, where you have requested us to do so, to contact you whether by email or phone; to administer and improve the site; to customise it to meet your particular requirements, for statistical purposes and occasionally for other purposes required by law or regulation. We recommend that you do not disclose information in these categories to us unless we specifically ask for it - if you do, we take it that by disclosing that information you give your consent to our using, disclosing and transferring that information in the same ways that we use, disclose and transfer any other information that we may hold about you.

Cookies
